# BUDGET

The 2024-2025 Multi-Year Budget presented by the Board of Police Commissioners to City Council was approved in November 2023. The 2025 Adjusted Budget presented by the Board of Police Commissioners to City Council was approved in December of 2024. Legislation requires an annual budget approval process.

## HIGHLIGHTS FROM THE 2025 APPROVED BUDGET

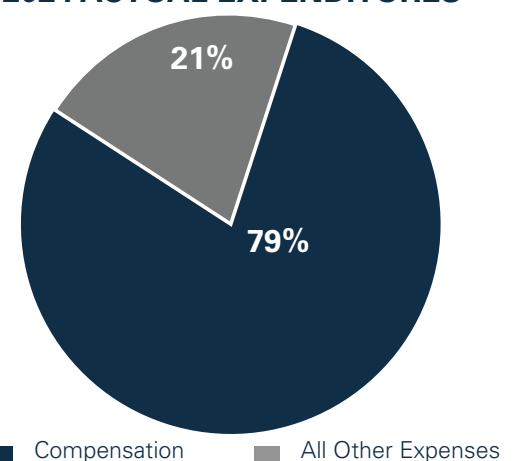
- Growth changes in police strength to maintain the service response in a growing city include the addition of four (4) Patrol Constables, three (3) Community Mobilization Unit Constables, one (1) Public Safety Constable, one (1) Air Support Sergeant and 28 provincially funded positions (four (4) 911 Communication Special Constables and 24 Safer Communities and Neighbourhoods (SCAN) Patrol Constables);
- Service level changes in police strength include the addition of one (1) Special Constable in Tech Crime to review devices associated with criminal offences from violence, organized crime, drug trafficking and homicide, and one (1) Constable in Serious Assault Unit to increase responsiveness with specially trained officers to work on complex serious assault cases; Service level changes in Administration include the addition of one (1) Health Professional in Human Resources to internally support mental health and wellness services in relation to traumatic encounters, one (1) Accounting Coordinator in Finance to support budgeting, reporting and forecasting;
- Operational changes include the impacts of inflation, collective bargaining and other operational expenses related to growth and service level changes in police strength;
- Planned projects utilize 66% of Saskatoon Police Service capital funds for replacing equipment and technology that are beyond the service life, and 34% for expanding equipment to support a growing City;
- Projects in 2025 include the replacement of in-car equipment (laptops, radios, and cameras), portable radios, specialized police team equipment, computer equipment, interview room recording equipment, furniture, network infrastructure CCTV Security Cameras;
- Capital expansion projects in 2025 include additional fleet units, network infrastructure, and body worn cameras.

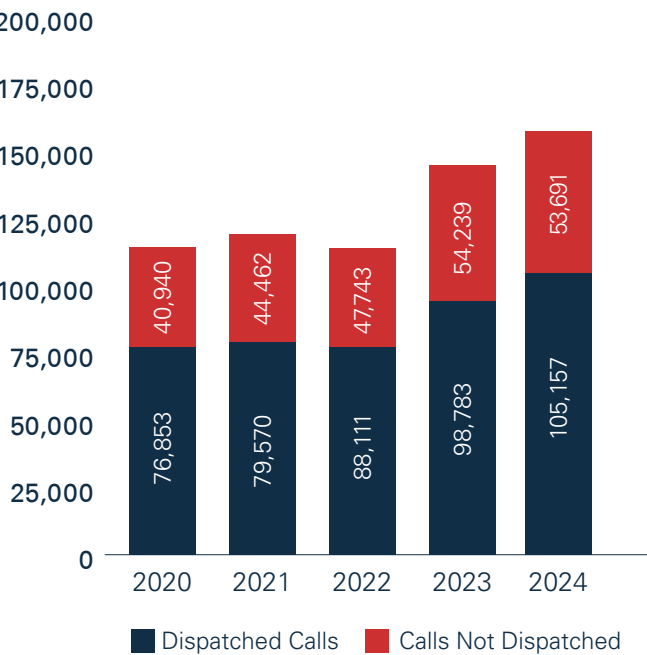
## 2024 ACTUAL EXPENDITURES

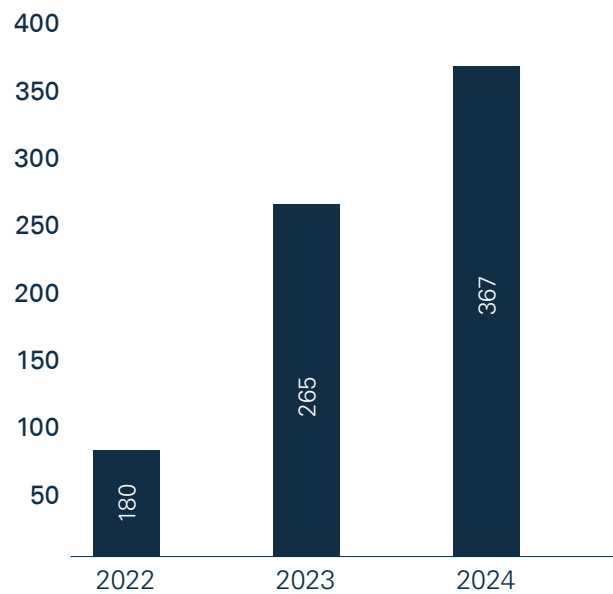

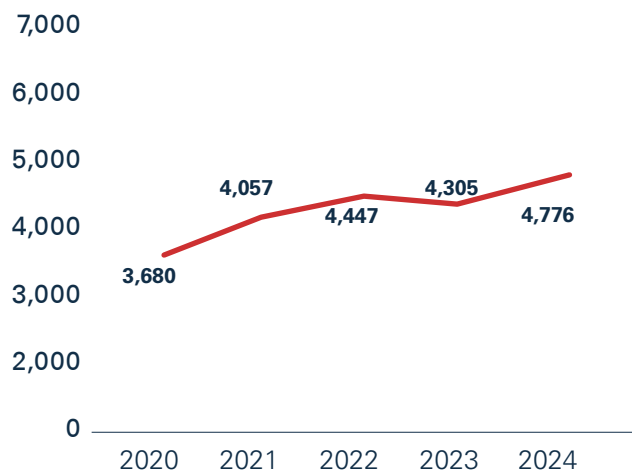
### BEAR SPRAY/BURNING LIQUID



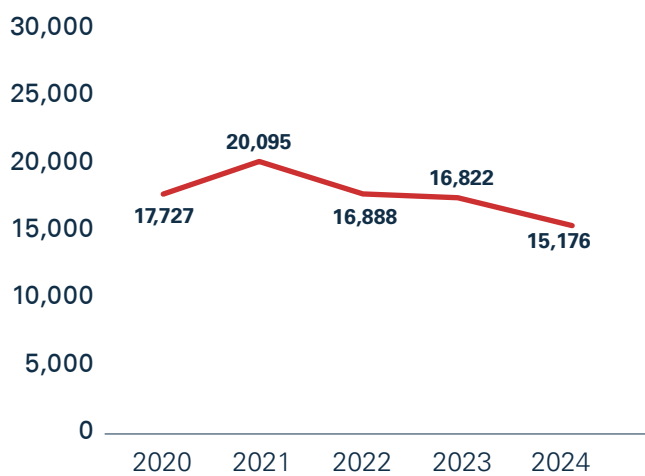
## TRAFFIC SAFETY

## **MACKENZIE TROTTIER REMAINS FOUND**

After 22-year-old Mackenzie Lee Trottier went missing in December of 2020, the SPS began investigating and identified a suspect in Mackenzie's disappearance. Before investigators could obtain the evidence required to prove their involvement, however, the suspect died in an unrelated incident. Evidence recovered from electronic devices belonging to the suspect supported the search of the City of Saskatoon landfill for Mackenzie's remains.

Police and purpose-trained dogs methodically searched a calculated area for evidence. After 93 days, Mackenzie's remains were found.

The search highlighted SPS teamwork, dedication and determination to provide closure despite challenging conditions including snow, rain, high winds, and extreme heat. The Public Safety Unit led a meticulous search of approximately 500 tonnes of refuse from the landfill. To complete such a complex task, they relied on critical internal and external partners such as the SPS Major Crime Section, Forensic Anthropologist Ernie Walker, City of Saskatoon, Saskatoon Fire Department, RCMP "E" Division, and Calgary Police Service support in preparation, equipment, and expertise to protect the searchers and be prepared for the challenging process. The SPS has since provided support to other police agencies in planning similar searches.

The SPS extends its most sincere condolences to Mackenzie's family and loved ones and is grateful for their trust, patience, and participation throughout a lengthy investigation.

## **SPOTLIGHT ON THE PSU**

The Public Safety Unit (PSU) is a part-time team comprised of members (seen on the cover) who applied for additional tasks and training on top of their full-time jobs in other areas of the SPS. Among their many skills, PSU members have specialized training for crowd management, search and rescue, and evidence recovery. The SPS relies on this team when there is a high-risk missing person or for complex searches such as the cases of Mackenzie Trottier or Megan Gallagher. They are also called on for security during large events, demonstrations, and other high-risk circumstances. The SPS would like to recognize and thank PSU members and the countless other employees and partners involved in the landfill search for their unwavering dedication, and service to the community.

## FORENSIC LABORATORY MATCHES SPENT CARTRIDGE CASES TO SEIZED FIREARM IN SEPARATE INVESTIGATIONS

On December 11, 2023, Saskatoon police responded to a report of multiple gunshots in the 700 block of Avenue H South. No victims were located or came forward to report. Police located several spent cartridge cases nearby and submitted them to the RCMP's national Forensic Laboratory Services (NFLS) for further analysis. Nine days later, during a separate investigation, police arrested a man and woman and seized a loaded firearm which was also submitted to the NFLS.

In March 2024, the NFLS notified the SPS that the cartridge cases from the December 11th investigation matched the firearm seized from the man and woman on December 20th. As a result, both people faced a series of firearm-related charges including intentionally discharging a firearm in a reckless manner.

In a continued effort to combat gun crime within our community and province, the temporary Firearms Ballistics Lab operated by the Saskatchewan Firearms Office was opened at the SPS in May 2024. The lab contains specialized equipment to expedite forensic results and conclude investigations more efficiently. The lab is connected to the national RCMP Shared Services Network and has access to the Canadian Integrated Ballistics Identification Network.



Additionally, the lab will:

- build intelligence on illegal firearms and analyze all firearms that are used for criminal activity and seized by police;
- strengthen the existing capacities to target, investigate and prosecute criminal activities involving gangs; and
- provide faster processing times, which could decrease the pre-trial time for the courts.

The SPS has been pleased to assist with the development and implementation of the Firearms Ballistics Lab.

## PROJECT PENSKE

The SPS Guns & Gangs Unit, with the assistance of the Tactical Support Unit, concluded an investigation that targeted firearms trafficking in Saskatoon on November 14, 2024. This investigation spanned several months and various locations within Saskatoon.

A total of 86 charges were laid against 10 individuals ranging in age from 17 to 37.

The individuals have been charged with offences including trafficking in controlled substances, breaching court ordered conditions and numerous firearms-related offences.

A total of eight firearms, one prohibited magazine, and approximately 70 grams of cocaine were seized as part of this investigation.





## PROJECT SEPARATE

The SPS Drug Unit, with the help other units in the SPS, carried out a nine-month investigation, called Project Separate, which investigated high level drug traffickers in Saskatoon. The investigation concluded in October when four individuals were arrested on a variety of drug trafficking charges for cocaine and methamphetamine.

Search warrants were executed at one commercial and four residential locations.

## 11-DAY VISIBILITY AND ENFORCEMENT PROJECT

An 11-day high visibility enforcement and crime disruption project targeted areas of increased criminal activity in Saskatoon in June. The project, developed by the Criminal Investigations Division with the support of the Special Uniform Operations Division, redeployed resources from the Crime Reduction Team, Break and Enter Comprehensive Action Program, Guns and Gangs Unit, and Tactical Support Unit in a highly visible capacity to respond to in-progress violent crime and conduct priority violent offender management.

As a result of this project, a total of:

- 567 proactive calls for service were generated by police officers leading to 117 arrests
- 182 new charges issued on 61 persons
- Several persons were also taken into custody on various outstanding warrants relating but not limited to drugs, weapons, assaults, and breach of conditions.

In addition to these arrests:

- 19 bladed weapons
- Eight firearms
- Seven cans of bear spray
- Eight blunt or assorted weapons were removed from the streets alongside drugs, ammunition, stolen property, and illegal cigarettes.







## MADDY'S LEMONADE STAND

On a warm afternoon in July, police were called to a home in the Westview neighbourhood, for a report that multiple boys had taken juice, money, and candy from a seven-year-old girl's lemonade stand. Upon arrival, officers obtained a description of the suspects, who had fled the scene. Shortly after relaying this information, another officer spotted the suspects in the 400 block of Confederation Drive.

Two boys, ages 14 and 16, were arrested. The 14-year-old was found to be in possession of a knife, and was charged with carrying a concealed weapon and breaching a court order. The 16-year-old was arrested on outstanding warrants.

This story has a sweet ending, as Maddy's lemonade stand obtained considerable attention and support from the Saskatoon community. Maddy received numerous donations to her GoFundMe account and was invited to sell her lemonade at other community events including the Saskatoon Berries games. The SPS commends Maddy's parents for reporting this incident quickly. Thanks to their swift actions, the suspects were caught and no longer able to turn anyone else's day into lemons.

# NEW INITIATIVES

## EXTERNAL RECOMMENDATIONS/ AUDITS

In September, 2022 the SPS entered into an agreement with the Office of the Treaty Commissioner (OTC) to collaborate on a strategic initiative to develop authentic and measurable indicators and initiatives specific to the SPS for responding to the National Calls (UNDRIP, TRC Calls to Action, MMIWG2S+ Calls for Justice, Rights of a Child, UN Sustainability Goals, etc.). The initiative also strengthened the SPS' relationship with the OTC.

Another effort began in the fall of 2023, when the SPS partnered with CultureAlly to complete a comprehensive assessment and vision for the Service's Equity, Diversity and Inclusion (EDI) activities. This work included gaining a full understanding of the current state of EDI at the SPS. This was done through different methods of data collection including a staff survey, assessments of existing policies and other written reports, audit and benchmarking against similar organizations in the policing sector. The work included the development of a comprehensive plan with recommendations for the SPS to achieve our long-term EDI objectives.

Both of these initiatives resulted in fulsome reports and initiatives which will inspire activities in SPS business plans and guide work for years to come



## ANATOMY OF A HOMICIDE

In 2024, 14 homicides placed significant pressure on resources due to the complexity of these investigations. To illustrate the critical and intricate efforts involved in the initial hours of a major crime response, an eight-minute video and summary were produced. These materials analyze a 2022 homicide on Melrose Avenue, offering insight into the coordinated response required during such incidents. The video, which has been viewed more than 1,000 times, highlights the resources and duties involved in the initial response including:

- Communications Special Constables making 72 dispatches of 54 officers, at multiple locations
- Life-saving measures
- Securing the area and minimizing the possibility of continued violence
- Guarding scene, suspects, if there and victims
- Identifying victims, suspects, and witnesses
- Canvassing the immediate and relevant areas for cameras and witnesses

- Forensic investigation
- Warrants for Major Crime Investigation
- Consultations with Crown, Coroner, and Public Relations and Strategic Communications Team

The initial call response lasted 38 hours, affecting overtime, officer availability, and stress levels as the SPS worked together to ensure public safety.

This singular investigation included 139 exhibits, 64 items sent for DNA testing, 13 witness interviews and resulted in over 120 hours of overtime. It also resulted in a backlog of calls for service which continued to affect workload in the following days.

One man was convicted of manslaughter while another was charged with first degree murder and one remains on the run. This homicide was also featured on Global TV's Crime Beat series in 2024. Visit the SPS YouTube channel to see the video: <https://www.youtube.com/watch?v=Kfb6DeUV3Sk>



# OUR PEOPLE

The SPS experienced a period of significant transition as Dave Hays was appointed Interim Chief during the search for SPS' new Chief of Police. Following the appointment of Chief Cameron McBride, a 27-year SPS member, Hays and Darren Pringle were named Deputy Chiefs. This leadership team prioritized stability, the well-being of SPS employees, and the continued pursuit of a safe city embracing community.

## CHIEF CAMERON MCBRIDE

During his career, Chief McBride has worked diligently to build and strengthen the community through both his career and personal endeavors.

Professionally, Cameron has built strong working relationships with community-based organizations. He has sat on numerous boards and committees including the Safe Community Action Alliance Operations and Administrative Committees, the Safe Consumption Site Community Safety Advisory Board, EGADZ Youth Centre, the Street Activity Sub Committee and the Downtown Safety Committee. He currently sits on the Board of the Restorative Action Plan Board and is the Chair of the CISS Provincial Executive Committee.

Personally, Cameron and his wife are dedicated to the community. Their work has included investing in non-profit organizations, specifically involving children in



need. The couple also works with police members on marriage enrichment and the challenges the career presents for members' families.

In his role as Chief of Police, Cameron continues to be involved in all aspects of contributing to a safe, healthy, and vibrant Saskatoon, while advocating for the wellness of SPS employees.

## DEPUTY CHIEF PRINGLE

Deputy Chief Darren Pringle was appointed Deputy Chief in June of 2024. He has over 28 years of experience, including 25 with the SPS. His education includes a Bachelor of Arts in Sociology, a Bachelor of Social Work, a Master of Defense Studies with research focus in Organizational Change Management, and a Certificate in Risk Management. He is a Registered Social Worker with the Saskatchewan Association of Social Workers, serving as a Practicum supervisor for students completing Social Work studies through the University of Regina.

Concurrent to his policing career, D/C Pringle has spent over 20 years in the Canadian Armed Forces



Reserves. He has been recognized with the Order of Merit of Police Forces, Canadian Forces' Decoration, Police Exemplary Service Medal, Queen Elizabeth II Platinum Jubilee Medal, and the Saskatchewan Protective Services Medal.

**DEPUTY CHIEF HAYE**

Deputy Chief Haye was temporarily appointed Interim Chief of Police in January 2024 until the position was filled and he was appointed Deputy Chief of Support Services in June 2024 with over 43 years of policing experience, 39 of which have been with the SPS. D/C Haye was born and raised in the Saskatoon area. He is a graduate of Mount Royal Collegiate and, later on in his career, Royal Roads University in Victoria, B.C. with a Bachelor of Arts Degree in Justice Studies. Prior to his career in municipal policing, D/C Haye joined the Canadian

Armed Forces Military Police where he was posted at CFB Moose Jaw.

He has been recognized with the Order of Merit of Police Forces, Police Exemplary Service Medal, Queen Elizabeth II Platinum Jubilee Medal, and the Saskatchewan Protective Services Medal. Deputy Chief Haye says he will continue to promote the values and beliefs which have made the SPS the highly professional organization it is today; a modern policing organization rooted in innovation, collaboration, and relationship building.
